**WHEREAS**, the BAC has endorsed the submissions Excel Worldwide Marketing Corporation to TWG as per BAC Resolution No. 081(A), S-2022 dated December 5, 2022;



**WHEREAS**, on December 12, 2022 the BAC has received the evaluation report for Excel Worldwide Marketing Corporation disclosing that it did not meet the technical specifications set by COWD, hence the proposal is non-responsive per Endorsement No. 2022-066 dated December 7, 2022;

**WHEREAS**, further evaluation was conducted on December 20, 2022 and the BAC has declared Excel Worldwide Marketing Corporation as non-responsive and further declared AVK Philippines Inc. as the supplier with the Second Lowest Calculated Quotation;

**WHEREAS**, the BAC has deemed it necessary to seek the assistance of the Technical Working Group (TWG) in the post-qualification of the documentary requirements and product being offered by AVK Philippines Inc.;

**WHEREAS**, the BAC has endorsed the submissions of AVK Philippines Inc. to TWG as per BAC Resolution No. 081(B), S-2022 dated December 20, 2022;

**WHEREAS**, on January 18, 2023 the BAC has received the evaluation report for AVK Philippines Inc. disclosing that it has met the technical specifications set by COWD, hence the proposal is responsive per Endorsement No. 2022-066(A) dated January 17, 2023;

**WHEREAS**, re-evaluation was conducted on January 19, 2023 and the BAC has severally moved and severally seconded to declare AVK Philippines Inc. as the supplier with the Second Lowest Calculated and Responsive Quotation; and

**NOW, THEREFORE**, WE, the members of the Bids and Awards Committee, hereby RESOLVE, as it hereby RESOLVED:


- a) To declare AVK Philippines Inc. as the supplier with the Second Lowest Calculated and Responsive Quotation for the PR No. 22-07-07-0123 re-canvass per specifications, in the amount of **₱499,635.80** only;
- b) To recommend for approval to the General Manager of the Cagayan de Oro City Water District the foregoing findings.


